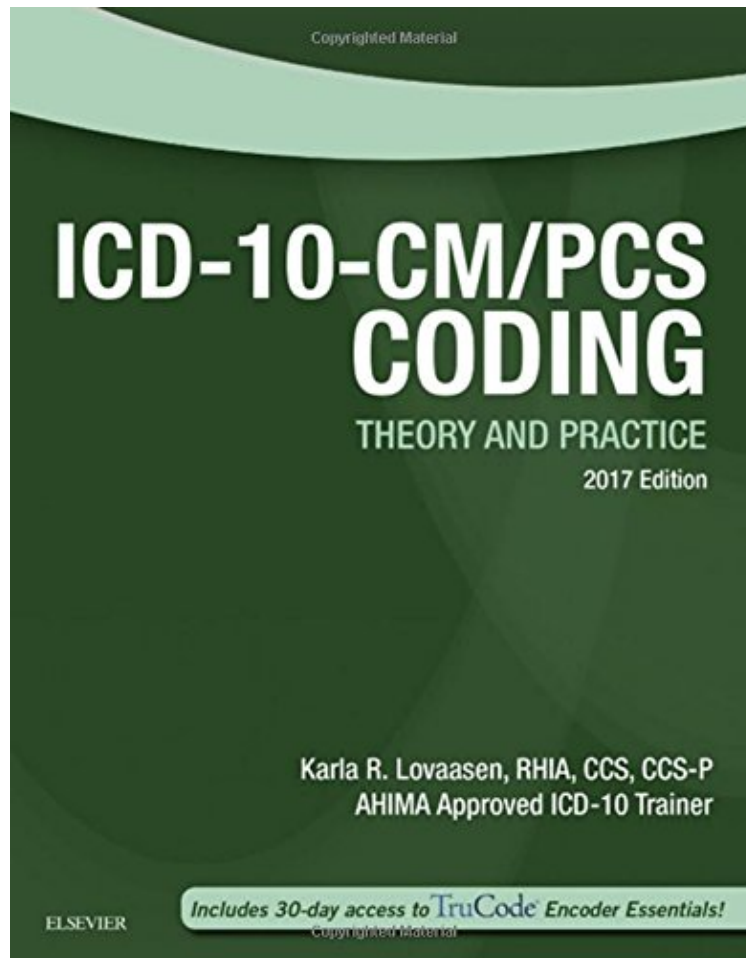

Contrary to some public opinion, he remarks in the foreword, European jurisprudence is not confined to sovereignty or to the curvature of bananas. It has been gently woven into UK statute and case law. If we are to throw out the bathwater, we must take great care to observe what might go with it, let alone what might replace it. As yet, one might be forgiven for the impression that family lawyers are getting on with the business of representing and protecting the most vulnerable in our society, and have little time, let alone the appetite, for looking into the unknown.
