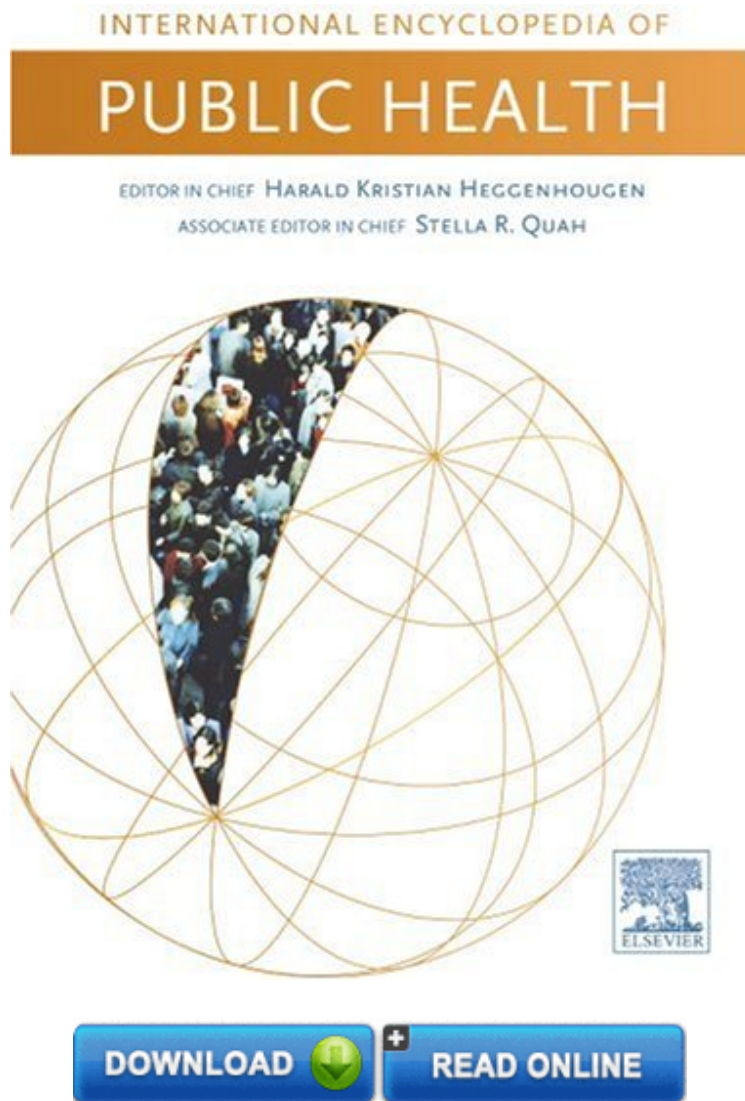

The entries fall into 30 sections outlined in a subject classification in volume 1. Sections include fundamental areas such as health promotion, economics and epidemiology, specific diseases such as cancer, particular populations, and many other topics. Global aspects of public health are especially well represented, including overviews of the health care systems of several countries and regions, and attention to health concerns of both the developed and developing world. A diverse, accomplished group of 30 section editors oversaw the efforts of 500 authors from around the world, and all entries have been peer reviewed. The set features numerous illustrations, many of them in color, and an exhaustive index. The encyclopedia is also available online through ScienceDirect (CH, Sep'06, 44-0034).
